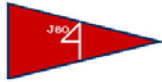

He must further insure that all equipment is properly maintained and stowed, and that the crew knows where it is kept and how it is to be used. It is also the sole and exclusive responsibility of the captain to decide whether or not to start or continue any race. The organizers/sponsors bear no responsibility for accidents, damage, or injuries to yachts or their personnel arising from any cause during this race or related activities.</p> <p>CERTIFICATION AND WAIVER I hereby certify that I have read the above-entitled CAPTAINS RESPONSIBILITY. I hereby agree that neither I, nor any of my crew shall hold the sponsors or any of their officers, directors, trustees or committee members responsible for accidents, damage or injuries during the race or related activities. No crewmember will be aboard my boat that has not consented to this waiver in his or her behalf. Nothing herein shall waive any claim which I or my crew members may have against any officer or member of the sponsoring club acting in his/her individual capacity as a participant in the race as captain or crew member of any yacht competing in this race.
